NEW YORK STATE-APPROVED DRIVER EDUCATION FOR HS STUDENTS—FALL 2022

PLEASE READ THE ENTIRE APPLICATION CAREFULLY.

APPLICATIONS ARE PROCESSED ON A ROLLING BASIS. THE APPLICANT MUST HAVE THEIR LEARNER'S PERMIT TO APPLY (NO EXCEPTIONS), AND A PHOTOCOPY MUST BE SUBMITTED WITH THIS APPLICATION.

Course Information: This 16-session program includes 24 hours of classroom instruction, which includes homework, a midterm, and a final. Additionally, there will be 24 hours of group driving instruction (four students per car), which includes 6 hours behind the wheel per student. It is expected that students practice driving outside of class with their parent/guardian.

Enrollment Requirements: You must be a high-school student, at least 16 years of age, who resides in the Great Neck Public School District (at least 16 years of age). You must submit a copy of your Learners Permit with your application. Applications will only be accepted if space remains. Applications will be accepted until a day before the first session begins **IF** space remains. If you have not made arrangements to obtain a Learner Permit (once you have turned 16), please refer to the New York State Department of Motor Vehicles Web site for detailed information at www.dmv.ny.gov.

Application Procedures

All of the following information MUST be provided before your application can be processed (no exceptions):

- Completed and signed Fall 2022 Driver Education fillable application. (attached)
- Copy of the student's learners permit.
- Your choice of theory class.
- Three (3) preferences for the driving class. If you do not indicate 3 choices, your form will be returned.
- Spaces are not held by phone and registration cannot be completed by phone.

More information:

- Tuition is \$645 payable by check to "Great Neck Public Schools" or by Visa, MasterCard, American Express or Discover completed on the application. There will be no refunds or credits for drops or withdrawals.
- Spaces are not assigned without the receipt of all signed paperwork.
- Email the completed application and learner's permit to gncontinuinged@greatneck.k12.ny.us. Applications may also be brought to our offices at 30 Cumberland Avenue. **Please do not bring to the High Schools.** Registrations are accepted on a first-come, first-served basis until all spaces are filled. Once the maximum has been reached, registration will be closed. Please file your application as soon as possible.

Permit information: Application for a New York State Learner Permit at the DMV (once you have turned 16), requires presentation of legal forms of identification, including an *original* social security card and *original* birth certificate. Be sure to have these documents with you when you go to the Motor Vehicle office or you will be turned away, and issuance of your permit will be delayed. **Please be sure to view all requirements on the New York State DMV Web site, www.dmv.ny.gov.**

Attendance: Attendance at all Theory and car instruction classes is **mandatory**. According to State Law, any absence and/or lateness must be made up. Unexcused absences may result in dismissal from the program. Please be sure you can attend and be on time for all sessions before you register. Team practices and games and/or other school activities are not excused absences. If class is canceled due to school district closure or instructor absence, a makeup session will be provided. If a student is absent from class, he/she is responsible to discuss makeup availability with the theory teacher.

Upon Completion: Students who successfully complete the requirements for this non-credit course will receive a Student Certificate of Completion (MV-285), which includes an Insurance Premium Reduction certificate. This form, issued once attendance rosters and grades have been reviewed and confirmed, allows students to make a road test appointment. After receiving the MV-285 and passing the road test, a 17-year-old is eligible for a full, New York State senior license; a 16-year-old is only eligible for a junior license, with restrictions. (Without completion of a state-approved Driver Education program, a NYS senior license is not issued until age 18.)

Classes: The theory classes will be held after school at North and South High Schools. Classes will be on Wednesdays at North High School at 2:45pm and 4:15pm in Room 103 and Thursdays at South High School at 2:45pm and 4:15pm in Room 704. **Students are required to attend classes in their own school.**
